- A thirty (30) year limited warranty covers any other type of building or property including those owned by corporations, governmental agencies, partnerships, trusts, religious organizations, schools, condominiums, homeowner associations, cooperative housing arrangements and apartment buildings. The warranty period will be thirty (30) years following the original date of Product purchase.

What is covered: Catalyst™ Fence Solutions warrants that its aluminum and/or steel fencing products ("Product") will be free from defects in material and workmanship for the warranty period. This limited warranty is valid beginning on the date of Product purchase.

Catalyst Fence Solutions warrants the Product against peeling, flaking, rotting, chipping, cracking, blistering, splintering, corrosion and rusting; or abnormal discoloration/fading* under normal atmosphere and weather conditions.

**After prolonged exposure to outdoor environments, all products will experience some gradual fading over time and is considered normal (up to a standard variation determined by Delta E color measurement, not to exceed Delta 5). Degrees of fading vary depending on geographical location, air pollution, exposure and other factors.*

What this warranty does not cover: This limited warranty does not cover damage resulting from: misuse, abuse, improper storage or handling, improper installation, other aluminum and vinyl products and accessories that are not manufactured by Catalyst Fence Solutions, damage caused by events beyond human control including but not limited to damage caused by animals or natural events; impact of foreign objects, fire, earthquake, flood, lightning, hail, hurricane, tornado or other casualty or act of God; movements, distortion, collapse or settling of ground or structure on which the fence is installed. This limited warranty does not cover costs of removal or disposal of product, or reinstallation of replacement product.

The thirty (30) year limited warranty for commercial installations cannot be transferred.

- This limited warranty covers single-family residential properties, buildings or property including those owned by corporations, governmental agencies, partnerships, trusts, religious organizations, schools, condominiums, homeowner associations, cooperative housing arrangements and apartment buildings.
- The warranty period shall begin the date of Product purchase.
- The length of warranty is determined by the table below.

Fence Installations 0 to 1 Mile from Salt Water Coast Line	5 year
Fence Installations >1 to 10 Mile from Salt Water Coast Line	10 years
Fence Installations >10+ Miles from Salt Water Coast Line	20 years

What is covered: Catalyst™ Fence Solutions warrants that its steel fencing products ("Product") will be free from defects in material and workmanship for the warranty period. Catalyst Fence Solutions warrants the Product against cracking, peeling, blistering and extensive corrosion*, or abnormal discoloration/fading** under normal atmosphere and weather conditions.

**Corrosion is determined extensive when multiple rust-through perforation instances occur on the same fence section or component.*

***After prolonged exposure to outdoor environments, all products will experience some gradual fading over time and is considered normal (up to a standard variation determined by Delta E color measurement, not to exceed Delta 5). Degrees of fading vary depending on geographical location, air pollution, exposure and other factors.*

This limited warranty is valid beginning on the date of Product purchase.

What this warranty does not cover: This limited warranty does not cover damage resulting from: misuse, abuse, improper storage or handling, improper installation***, other steel products and accessories that are not manufactured by Catalyst Fence Solutions;; impact of foreign objects, fire, earthquake, flood, lightning, hail, hurricane, tornado, high winds or other casualty or act of God; movements, distortion, collapse or settling of ground or structure on which the fence is installed; weathering/discoloration due to UV or temperature; pollutants and chemicals including pool, lawn, garden and ice removal chemicals; staining from foreign substances; exposure to salt water if proper care and maintenance is not adhered to. This limited warranty does not cover costs of removal or disposal of product, or reinstallation of replacement product.

**** Proper installation requires the following steps when a section is cut the length. 1. Clean the cut area and remove all shavings/burrs. 2. Coat the cut edge with a zinc rich primer and let dry. 3. Apply touch up paint to match fence color. Omission of these steps will negate the warranty.*
